Other required minimum criteria for engagement as Interns shall be as per PMIS. Salient criteria are as follows:

1. Age:

Minimum 21 years and Maximum 24 years. Relaxation in upper age limits to reserved category will be as per PM Internship Scheme.

2. Ineligibility Criteria: The following person are ineligible to participate

a) Graduates from IITs, IIMs, National Law Colleges, IISER, NIDs & IIITs

b) Those having qualification such as CA, CMA, CS, MBBS, BDS, MBA any master's or higher degree.

c) Those undergoing any skill, apprenticeship, internship or student training programme under Central Government or State Government Schemes.

d) Those who have completed apprenticeship training under National Apprenticeship Training Scheme(NATS) or National Apprenticeship Promotion Scheme(NAPS) at any point.

e) If the income of any of the family members of the candidate exceeds Rs.8 Lakh for Financial Year 2023-2024.

f) If any member of the family is a permanent/regular government employee

3. Monthly assistance:

Monthly assistance of Rs. 4,500/- will be paid to the interns from the Govt. of India for the entire duration of 12 months of the internship as per PMIS.

In addition to this UCIL shall pay Rs. 3,500/- per month to each intern for entire 12 months period.

Besides the above a one-time grant for incidentals of Rs.6000/- will be disbursed to each interns by the Government through Direct Benefit Transfer(DBT) as per PMIS.

4. Other facilities:

UCIL shall also provide accommodation and transport facilities to the engaged interns from its township on free of cost basis subject to availability. In addition to this, the engaged interns shall also provided with food facilities in UCIL canteen on chargeable basis during daily duty hours.

5. How to apply:

- a) The scheme will be implemented through an online portal www.pminternship.mca.gov.in.
- b) Eligible candidates need to register themselves on the Portal. Based on the information provided by the candidates, a resume will be generated by the Portal.
