Recruitment of Assistant Engineers (Electrical, Mechanical & Civil) in Haryana Power Utilities viz. HVPNL, HPGCL, UHBVNL & DHBVNL on the basis of valid score of GATE-2023/ GATE-2024/ GATE-2025 or score of GATE- 2022 (as one time measure).

1. Haryana Power Utilities (HPUs) i.e. Haryana Power Generation Corporation Limited (HPGCL), Haryana Vidyut Prasaran Nigam Limited (HVPNL), Uttar Haryana Bijli Vitran Nigam Limited (UHBVNL) & Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL) are carrying out the work of Generation, Transmission and Distribution of electricity in the State of Haryana. Haryana Power Utilities (HPUs) have decided to undertake recruitment of Assistant Engineer/ Electrical cadre and Assistant Engineer/Civil cadre against the available vacant posts meant for direct recruitment on the basis of valid score of GATE-2023/ GATE-2024/ GATE-2025 or score of GATE- 2022 (as one time measure).

2. The score of GATE-2022 is also being considered in the present recruitment as one-time measure under relaxation of rules and it shall not be treated as precedent for future recruitment(s), as earlier recruitment process initiated vide advertisement dated 20.12.2022 was cancelled through public notice dated 25.04.2025, therefore, all the candidates who had applied against advertisement dated 20.12.2022 are required to apply afresh provided & otherwise eligible for the same and fulfils the eligibility criteria. Further, the criteria for selection for the post of Assistant Engineer has undergone change, therefore, any claim whatsoever, with respect to earlier advertisement dated 20.12.2022 and public notice dated 25.04.2025 shall not be entertained. In case of candidates who have appeared in multiple GATE exam (GATE-2022 or GATE- 2023 or GATE-2024 or GATE-2025), they have the option to apply for the post advertised on the basis of highest/ maximum individual score of GATE-2022 or GATE- 2023 or GATE-2024 or GATE-2025 as the case may be.

Haryana Power Utilities (HPUs) viz. Haryana Vidyut Prasaran Nigam Limited (HVPNL), Haryana Power Generation Corporation Limited (HPGCL), Uttar Haryana Bijli Vitran Nigam Limited (UHBVNL) & Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL) invite applications for the post of Assistant Engineer/ Electrical Cadre, Assistant Engineer/ Mechanical under Electrical Cadre and Assistant Engineer/ Civil cadre from the eligible candidates, **who have qualified/ cleared the GATE-2022/ GATE-2023/ GATE-2024/ GATE-2025 exam as the case may be and fulfill the qualification criteria of the HPUs as given in para-3 below.**

3. The essential qualification of various disciplines with respective code of GATE paper as the case may be, for the post of Assistant Engineer/ Electrical Cadre and Assistant Engineer/ Civil Cadre is given here as under:-

5. Reservations / Relaxations / Concessions:

- Reservation / Relaxation / Concession, wherever applicable, are applicable to Haryana domicile candidates only, subject to reservation policy.
- The benefit of reservation will be given to those SC (DSC/ OSC)/ BC (NCL)/ PwD/ ESM & EWS candidates who are domicile of Haryana State only.
- The criteria for exclusion of candidates who belong to Creamy Layer from Backward Classes shall be governed as per State Government notification issued from time to time. The BC-A/ BC-B candidates who fall in within the creamy layer are not eligible to claim any benefit of reservation of BC-A/ BC-B category. Such candidates should submit their application form under General category. They will be treated as General

- category candidates for all purposes & intent and they have to pay full fees as meant for General category candidates.
- iv. The women candidates seeking reservation under SC (DSC/ OSC) /BC-A (NCL)/ BC-B (NCL) category are required to submit the Caste Certificate issued by the Competent Authority from Parental Side (Father's side) only. It should be noted that Certificate from in-laws (Husband's Side) will not be entertained.
 - v. Candidates belonging to reserved categories of States, other than Haryana, shall be considered as General category candidates and treated against Un-reserved vacancies.
 - vi. The reservation of posts for different categories is governed by the instructions of State Government of Haryana as issued from time to time.
 - vii. Reservation / Relaxation / Concession wherever applicable, is subject to uploading of scanned copy of certificates in the format prescribed by Government of Haryana and issued by the Competent Authority, during the submission of online application form. The original certificates shall be checked at the time of verification/ checking of documents.
- 6. Persons with Disabilities:**
- i. Only such Persons with Disabilities (PwD) of Haryana Domicile would be eligible for reservation in service/posts who suffer from not less than 40% (40 percent) of relevant disability.
 - ii. PwD candidates of Haryana Domicile shall be given reservation, age relaxation & fee concession, as per Government of Haryana directives.
 - iii. PwD candidate would have to upload a scanned copy of Disability certificate issued by Competent Authority in the format prescribed by Government of Haryana, during the submission of online application form. The original certificates shall be checked at the time of verification/ checking of documents.
- 7. Nigam/ Corporation Candidates:**
- i. Nigam/Corporation Candidates of HPUs in order to be eligible for direct appointment as Assistant Engineer are also required to qualify in the corresponding paper of GATE-2022 or GATE-2023 or GATE-2024 or GATE-2025.
 - ii. The Nigam/Corporation eligible candidates of HPUs are required to apply online and shall forward copy of print out of their online application form to respective existing cadre controlling authority of his/ her Utility through proper channel on or before **04-11-2025**.
 - iii. Nigam/Corporation candidates of HPUs should upload a scanned copy of the ID card issued by respective Haryana Power Utility, during submitting online application form.
 - iv. The names of only such eligible Nigam/Corporation candidates of HPUs forwarded by respective HPUs shall be considered for selection. Mere forwarding of name does not make an employee eligible for selection.
 - v. Nigam/Corporation candidates of HPUs are not exempted from Application fee.
 - vi. In case of selection of Nigam/Corporation candidate, no benefit of past service whatsoever rendered in Nigam/Corporation will be admissible. He/ She will be treated as fresh entrant for all intents and purposes.
- 8. Ex-Servicemen (ESM):**
- i. The reservation to Ex-Servicemen of Haryana will be given as per instructions issued vide No. 12/15/2019-4GS-II dated 09.03.2022 and further clarified vide letter even No. dated 13.04.2022 by the State Govt. of Haryana.
 - ii. Upper Age limit is relaxable for an ex-military person whether he joined military service before or after the declaration of emergency to the extent of his military service added by three years provided he had rendered continuous military service for a period of not less than six months before his release and further provided that he had been released otherwise than by way of dismissal or discharge on account of misconduct or inefficiency.
 - iii. If suitable ESM of Haryana are not available only then dependent family members (son, daughter or spouse) of ESM will be considered against the posts reserved for ESM.
 - iv. The dependents of ESM candidates will be considered as General/ SC (DSC/ OSC)/ BC-A (NCL)/ BC-B (NCL) Category (their own category) candidates for all intents and purposes.
 - v. The dependent sons/daughters of ESM who fulfil all conditions of qualifications, age etc. prescribed for posts will be considered on merit for the posts reserved for ESM to the extent of non-availability of suitable ESM candidates. This entitlement would be available to one dependent family member (son, daughter or spouse) only.

- vi. Candidates claiming dependent family member (son, daughter or spouse) of Ex-Servicemen must upload the scanned copy of latest eligibility certificate issued by Secretary, Zila Sainik Board, Haryana in view of the State Government instruction No. 12/15/2019-4GS-II dated 09.03.2022 and further clarified vide letter even No. dated 13.04.2022 in support of their claim during the submission of online application form. The original certificates shall be checked at the time of verification/ checking of documents. Mere dependent certificate will not be entertained.
- vii. None of the persons mentioned below shall fall within the definition of word "Dependent of Ex-Servicemen" :
- (a) A person may be unemployed at the time of making the application but he may have other source of income viz. from agriculture, trade, property, bank balance etc.
- (b) A person may be working on adhoc basis on the post advertised or somewhere else.
- (c) A person who is a member of Joint Hindu Family and remains dependent upon the Karta till there is partition in the family or he ceases to be a member of the Joint Hindu Family and is obliged to pass on all his income to Karta and draws money for his subsistence from the pool of the Joint Hindu Family with the consent of the Karta.
- (d) A person who is a member of the Joint Hindu Family is employed on adhoc basis but he is otherwise dependent on his father.
- viii. The dependents of ESM are required to pay the fees as applicable for Gen, SC & BC (NCL) category candidates as the case may be.

9. Reservation for Freedom Fighters & their children/ grandchildren of Haryana:

- i. The reservation will be applicable only if quota reserved for Ex-Servicemen (except Schedule Castes) or Backward Classes remain unfilled to that extent due to non-availability of suitable Ex-Servicemen or their dependents or non-availability of suitable candidates from Backward Classes as per the latest State Government instructions No. 20/49/2021-1GS-III dated 27.10.2021 and further clarification issued vide instructions No. 22/49/2021-1GS-III dated 26.04.2022 on the subject.
- ii. Overall reservation either from the unfilled vacancies of Ex-Servicemen (except Schedule Castes) or from the Backward classes for Freedom fighters/ one of their children/ grandchildren will remain limited to 2% only.
- iii. This benefit will be available to a child or grandchild i.e. son or daughter of son and daughter (Paternal as well as Maternal) of the Freedom Fighters.

10. AGE LIMIT:

Eligibility of age limit is as on last date of submission/ receipt of application form i.e. **29-10-2025**. The age limit for the post of Assistant Engineer is **20 to 42 years**.

11. RELAXATION IN AGE LIMIT (FOR CANDIDATES OF HARYANA DOMICILE ONLY):

The relaxation in age limit is admissible to candidates of **Haryana Domicile only**. Upper age limit is relaxable as admissible under rules/registrations/instructions of HPUs/ Haryana Government. Relaxation in age in different categories, subject to the condition that the candidate is meeting other eligibility criteria for the post, is as given below:

- Note:-** 1 If benefit of age relaxation is admissible to a candidate for more than one of the categories mentioned above, then benefit shall be considered only for one of those categories which allows maximum age relaxation to the candidate.
- 2 The upper age limit of an applicant of any category (except Ex-servicemen) shall not exceed 52 years who is entitled to avail the benefit of relaxation in age of one or more categories mentioned above.
- 3 The age concession to SC (DSC/ OSC) /BC-A (NCL)/ BC-B (NCL)/ ESM candidates of Haryana shall be admissible only where the posts are reserved for these categories.
- 4 For the candidates at Sr. No. (x) above, for getting age relaxation, the experience certificate(s) of equivalent post issued by the Appointing Authority of respective Department/ Board/ Corporation/ Govt. aided Institution only shall be valid for consideration.

12. STUDENTS APPEARING IN FINAL YEAR/SEMESTER:

The candidates/ students appearing in final year/ semester having essential qualification as on **29-10-2025** will only be eligible to be appointed as Assistant Engineer/Electrical & Assistant Engineer /Mechanical under Electrical cadre and Assistant Engineer/ Civil cadre in Haryana Power Utilities i.e. HVPNL, HPGCL, UHBVNL & DHBVNL.

13. SELECTION PROCESS:

- The candidates who have acquired the essential qualification as mentioned at Sr.No.3 above and must have qualified the Graduate Aptitude Test in Engineering (GATE-2022/ GATE-2023/ GATE-2024/ GATE-2025) as the case may be, conducted by respective IIT/ IISc in corresponding paper i.e. Electrical Engineering (EE), Mechanical Engineering (ME) and Civil Engineering (CE) shall only be eligible to be considered for selection.

- ii. The selection of the candidates in each category would be done by the HPUs from the eligible candidates as given in para-(i) above, on the basis of score of Graduate Aptitude Test in Engineering (GATE-2022/ GATE-2023/ GATE-2024/ GATE-2025) in the respective discipline as per requirement of HPUs. The equal weightage would be given to GATE-2022 or GATE-2023 or GATE-2024 or GATE-2025.
- iii. The minimum qualifying cut-off marks in respect of GATE-2022/ GATE-2023/ GATE-2024/ GATE-2025 shall be as declared by GATE Organizing Institute (respective IIT/ IISc) for respective GATE paper/ discipline/ category given as under:-

- iv. The selection process consist of valid score of GATE (out of 1000) obtained in the corresponding paper of GATE-2023 / GATE-2024 / GATE-2025 or score of GATE-2022 (as one time measure). No interview will be carried out for the posts being advertised by HPUs. **The score of GATE- 2021 or prior will not be entertained.**
- v. The applicant would require to fill up the valid score of GATE (out of 1000) obtained in GATE-2023 / GATE-2024 / GATE-2025 or score of GATE- 2022 (as one time measure), **whichever is higher during online submission of application.**
- vi. Besides this, Educational qualifications must be from a recognized Institution/ University/ Board.
- vii. In case GATE score (out of 1000) of two or more candidates is equal then candidate older in age would be considered higher in merit. Further, in case age is also equal then candidate having more marks in essential qualification would be considered higher in merit.
- viii. The shortlisted eligible candidates numbering 2 times of advertised posts for a particular category (subject to minimum 4 nos.) would be called for verification/ checking of original documents/ certificates in order of Merit prepared on the basis of selection criteria mentioned above. The Nigam at its sole discretion may give extended chances to a candidate who due to some genuine constraints could not appear on scheduled date and time fixed for verification of original documents and certificates.
- ix. Waiting list equivalent to 10% (subject to minimum 2) of the posts advertised for a particular category will be prepared. The persons from the waiting list will be offered appointment against all vacancies falling vacant for any reason including due to resignation/ death of newly selected/ appointed incumbents during the period of validity of the waiting list. The waiting list would be valid for one year from the date of declaration of result in terms of Instruction issued vide memo No. 42/43/84-5GSI dated 20.01.1988 and amended from time to time.
- x. Offer of Appointment will be issued by respective HPUs to the selected candidates in the order of category wise Merit prepared on the basis of valid score of GATE-2023/ GATE-2024/ GATE-2025 or score of GATE- 2022 (as one time measure) and as per the preference indicated by the candidate in the application form and based on the requirement of HPUs.
- xi. The selected candidates for the post of Assistant Engineer will produce Medical Fitness certificate required for first entry into service from the Civil Surgeon of any district in Haryana State before joining the services.

14. **AMOUNT OF FEE (NON TRANSFERRABLE/ NON REFUNDABLE/ NON ADJUSTABLE):** The candidate is required to deposit the fee separately for each post applied for as per the details given below:-

15. **GENERAL INFORMATION:**
