Airports Authority of India (AAI) (Schedule – ‘A’ Miniratna Category-1 Public Sector Enterprise) was constituted by an Act of Parliament and came into being on 1st April, 1995 by merging erstwhile National Airports Authority and International Airports Authority of India. The merger brought into existence a single Organization entrusted with the responsibility of creating, upgrading, maintaining and managing civil aviation infrastructure both on the ground and air space in the country.

Airports Authority of India, IAU-RCDU Safdarjung Airport, New Delhi - 110037 is inviting applications for Apprenticeship Training Program in RCDU/FIU/CRSD & E&M Workshop & its related units – Safdarjung Airport, New Delhi – 110003. During the period of Apprenticeship, the candidates are governed by Apprentices Act 1961 (as amended in 1973 and till date) and commensurate policies/rules of the organization.

**A. Educational Qualification:** Candidates should possess full time regular four years degree in Engineering or regular three years diploma of the above mentioned streams, recognized by AICTE, GOI and regular three years degree from a recognized university as mentioned under Para 'A' at first page of this notification, for respective positions.

**B. Conditions:**

1. Apprentices shall have to undergo Apprenticeship training at RCDU/FIU/CRSD & E&M Workshop & its related units – Safdarjung Airport, New Delhi – 110003.
2. As per the provisions of the Apprentices Act, 1961 as amended from time to time, candidates who have already completed their apprenticeship or terminated their apprenticeship midway or are pursuing in other organizations or in AAI with the same qualification level or otherwise, are not eligible for engagement as apprentice.
3. As per the Apprentices Act, 1961, candidates who had job experience / training for a period of 1 year or more after the attainment of essential educational / professional / technical qualifications, are not eligible for engagement as apprentice.

**C. Mode of Selection:**

1. Provisional selection of the candidates would be merit-based & the decision of AAI shall be final and binding.
2. The final selection will be based on Interaction /verification of certificates/testimonials and submission of Medical Fitness Certificate at the time of joining.
3. **The shortlisted candidates will be called for Interaction/Document verification through their registered email IDs only, so always keep their email id active and regularly check their emails in Inbox & Spam Folder**
4. The selected candidates will be posted preferably at various Establishment in RCDU/FIU / CRSD & E&M Workshop & its related unit at Safdarjung Airport, New Delhi – 110003.

**D. Eligibility Criteria:**

1. Only Indian National are eligible. Preference will be given to Delhi / NCR Area.
2. Candidates passed degree/diploma **in 2021 or after 2021** only are eligible.
3. Age limit: Maximum Age 27 years as on **24.11.2025**

**E. General Instructions:**

1. **Last Date of receipt of application is 24/11/2025. No application shall be received after 1800 hrs of 24.11.2025 under any circumstances.**
2. The interested candidates are required to apply through BOAT's web portal [www.nats.education.gov.in](http://www.nats.education.gov.in) (for graduate/diploma apprentices) by finding establishment **Airports Authority of India – RCDU/FIU & E&M/Workshop, Safdarjung Airport, New Delhi NATS PORTAL ID : NDLNDC000087** ] and click the apply button in the next page. After successful application, the message "Successfully applied for the training position. Based on availability, you will be contacted by the establishment" will appear. In case of general stream candidates, may please submit their application on [ipaggarwal@aai.aero](mailto:ipaggarwal@aai.aero). The attachment strictly be in a single PDF File only.
3. **Candidates should register themselves with the concerned portal (NATS) prior to applying for apprenticeship training in AAI without fail.** Correspondence/Communication in any other manner will not be entertained.[ANNEXURE – 1]
4. No TA/DA will be provided. The no. of candidates to be engaged is indicative and may undergo changes without any further notification at the direction of AAI & the decision of AAI shall be final & binding.

5. During the period of apprenticeship, candidates will be governed by the Apprentices Act, 1961 (as amended in 1973 and till date) and the policies/rules of the organization.
6. Reservation for SC/ST, OBC and EWS as applicable will be followed, however, in case of non-availability of candidates in reserved category it will be filled from other reserved categories/general categories as the case be.
7. **Airports Authority of India has no obligation to give regular or contractual employment to Apprentices.** They shall have no right to claim regular or contractual employment from AAI on the basis of this apprenticeship at any point of time. This training program shall not create any liability on AAI for providing any job to the Apprentice. AAI management does not take any responsibility for any sort of employment/placement.
8. The decision of Management will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, and / or interchangeability of positions to be filled etc. No correspondence will be entertained in this regard. Filling up of the seats and their interchangeability (as the case be) is solely at the discretion of the management based on suitability of candidates and no claim will entertained, if some of these seats are not filled due to unsuitability/insufficient number of candidates.

10. It shall be the sole responsibility of the candidates to get their profile verified from the respective regional Board.
11. Candidates applying for more than one Discipline will not be considered and their application will be rejected.
12. **AAI does not take any Application Fee or any other type of fees etc for this purpose.**
13. **Influence, if any, will be taken into record & the candidature of such candidate shall not be considered under any circumstances. Decision of AAI shall be final & binding.**
14. **The candidature of the applicant would be provisional, subject to verification of certificates/testimonials and submission of certificate of Medical Fitness (to be obtained only from a Government Medical officer/Medical Officer of a Government Undertaking) at the time of joining.**
